Board of Directors' and Management's Annual Report to the Membership

RGV Credit Union spent 2024 upgrading! We upgraded our phone system to a Web-based system (Open Voice) that provides us with new tools to assist in providing more efficient member service. We also upgraded our computers at all 5 locations. Spectrum FIA was installed at all locations to provide independent fiber service. We also set up media conference rooms at Morgan, San Benito and 83 branches.

We have finalized members of our executive team in 2024 with the promotion of Sandra Gonzales to VP of Human Resources and Tami Donovan to VP of Compliance. Our executive team spent a significant amount of time negotiating and preparing for our Plastics Conversion to MAP and the installation of new Dolphin Debit ATMs in the first quarter of 2025.

We now have a Branch Manager at every location:

Morgan-Mary Carmona, San Benito-Amanda Cerrillo, 83-Melissa Cardona, Lyford-Martha Mendoza and Rio Hondo-Mona Shamlian

We feel that this provides excellent leadership at each location.

We launched Savvy Money, which is a credit and financial management tool for our membership through online and mobile banking. We have also revamped our contact center with the launch of Mini Branch which provides an AI assistant "Rio" who is able to assist our membership with 100s of common questions. This also provides a live chat option for our membership during business hours.

To say that we were extremely busy in 2024 is an understatement. I am extremely proud of how our staff worked as a cohesive team to accomplish all of this and still provided excellent member service.
