

## *Skip your November or December Loan Payment!*



This member clicks the contextual drop-down menu next to the loan.

This member selects Skip A Payment to see if they have a loan that qualifies. Eligibility is checked when the member selects to skip the payment.

The Skip-Payment request is available from It'sME247 online banking and from our mobile app. Click on the contextual drop-down menu next to the loan to begin the process.

Member must be in good standing and cannot be more than 17 days delinquent with no freeze codes present on account. **\$20 processing fee per loan. Only November or December due date eligible to be skipped.**

Account must be open for more than 180 days. Loan balance must be over \$750. Excludes: CD Secured, Share Secured, Loan Workouts/Visa in House, 500 Bucks, \$1000 Fast Cash, \$1500 Fast Cash Plus, Kasasa Helping Hand, & Leap Out of Debt Loans. Request must be received at least seven (7) business days prior to scheduled payment. \*Special terms and conditions may apply.

## USA Patriot Act

On September 11, 2001, our lives changed forever when our country was attacked. In an effort to protect you and our country from terrorism, President Bush signed the USA Patriot Act into law on October 26, 2001. Preventing terrorist financing is one way we can help prevent terrorism. We want you to know that section 326 of this Act requires our Credit Union to verify the identity of all new Credit Union members. We must also verify the identity of members and nonmembers added as signatories to, and who have access to, new or existing deposit accounts and loans. If you are an existing member who joined the Credit Union before the U.S.A. Patriot Act became effective, we may also need to verify and retain copies of any documents used to verify identity when you request anew deposit account, apply for a loan, or are added as a signatory to a new or existing deposit or loan account.

We ask for your understanding as we work to support these efforts to maintain the security of your funds and our country. Please speak with a Credit Union staff member if you have any questions or concerns about our identity verification process.
